Welcome and Introductions:

Minutes: The minutes for the 20 September 2016 meeting were accepted as written.

Reports: Dana Kress spoke on the "Administrative Diversity Advocate Proposal." Dr. Rowe did not approve this before he left. It was suggested and agreed on to re-submit proposal to the new president, Dr. Holoman. Dana will update the Quick Facts section before he submits the proposal. Dana also helped us understand the difference in police and procedure. Policy has to be voted on by the trustees. Procedure has to cleared by the cabinet, but not the trustees.

Hate Speech definition was sent to the Provost.

Centenary defines as hate speech any speech or expression that intends to harass, intimidate, threaten, or torment another person or persons on the basis of bias or prejudice towards some aspect of diversity. This includes, but is not limited to, expression related to race, gender, ethnicity, religion, sexual orientation, national origin, disabilities, and social or political beliefs. This definition does NOT cover the legitimate expression of political, social, or religious views, even if those views may be unpopular, or even offensive to some people. It applies *specifically* to expression that is primarily based on hostility towards a specific individual or group and *that* lacks a serious contribution to the discussion of public issues.

LaToya and Dana explained the history of the Hate Speech definition and the procedures for reporting hate speech.

What Not to Say Posters: Don asked where the posters were and discussed the possibility of taking the What Not to Say campaign on the road to High Schools. DJ has last year's posters and Ayanna will get them. All were in agreement for taking the posters to high schools.
